Pursuant to article 17 paragraph 2 of the Law on Public Roads ("Official Gazette of the RS", No. 101/05, 123/07, 101/11, 93/12 and 104/13),

Supervisory Board of the Public Enterprise "Roads of Serbia" on the meeting held on 19 January 2016 issued the following

## DECISION

## About the amount of fee for using state roads for vehicles registered abroad

1. This Decision sets out the amount of fee for using a state road in the Republic of Serbia for vehicles registered abroad.

2. Basis for calculating the fee referred to in item 1 of this Decision for freight vehicles, i.e. combination of vehicles is gross-ton kilometre and for a bus – vehicle-kilometre.

The term gross-ton kilometre referred to in paragraph 1 of this item implies the movement of one ton of total mass of a freight vehicle, i.e. a combination of vehicles over a distance of one kilometre.

Expression total mass of a freight vehicle, i.e. a combination of vehicles (including mass of fuel in the tank, apparatus and equipment) together with the mass of vehicle crew and the transported freight. Expression vehicle kilometre referred to in paragraph 1 of this item implies the movement of a bus over the distance of one kilometre.

Each started ton, i.e. started kilometre, shall be deemed as a whole ton, i.e. whole kilometre.

Calculation of travel distance in kilometers for certain distances is performed based on road chainage, prepared by state road manager for classified state roads in accordance with the rulebook prescribing marking method and public road register.

3. Coefficient for calculation of fees referred to in point 1. of this decision expressed in euros is for:

Trailer for transportation of luggage of passengers who travel by bus drawing a trailer is considered to be a part of the bus.

4. Amount of fee is obtained when basis referred to in point 2. of this decision is multiplied by corresponding coefficient referred to in point 3. of this decision.

5. The fee is charged in effective foreign cash in accordance with the Decision on Types of Foreign Exchange and Foreign Cash to be Purchased and Sold in the Foreign Exchange Market ("Official Gazette RS", No. 98/12, 143/14 and 51/15).

6. This Decision, upon being approved by the Government, shall be published in "Official Gazette of the Republic of Serbia" and shall enter into force on the 8th day following the day of its publication.
